The Vice-Chancellor, based on the permission granted by the National Council for Teacher Education, Bangalore, the State Government of Andhra Pradesh, on the recommendation of the duly constituted Inspection Committee and pending ratification by the academic bodies/the Executive Council, has accorded approval for the extension of temporary affiliation to **Sravanthi College of Education, Dharmaram, Warangal District** to offer B. Ed. Course with an intake of one hundred (100) students for the academic year 2014-2015.

The extension of temporary affiliation is subject to fulfillment of the conditions set by the NCTE, Bangalore, the Government of Andhra Pradesh and the following specific conditions:-

1. Two more staff members already working should be ratified by the university;
2. Laboratories are to be further improved;
3. Library is to be added with books worth Rs. 50,000/-.
4. Language lab is to be established;
5. To remit affiliation and other fee as per University norms;

Further, the management should comply with the aforesaid conditions and send compliance report to this effect within **(1) one month** from the date of issue of these orders, failing which, the temporary affiliation will be withdrawn.
